The Long-Term Energy Solutions program is to provide long-term solutions and energy efficiency upgrades in affordable housing to help low-income Coloradans reduce energy use and lower their bills. Current contracts with Xcel Energy, Atmos Energy, Source Gas, Colorado Natural Gas (CNG), Holy Cross, San Miguel Power Authority (SMPA), Platte River Power Authority (PRPA) are restricted to provide upgrades in their utility service territories.

The objective of the Weatherization Assistance for Low-Income Persons (WAP) program is to increase the energy efficiency of dwellings owned or occupied by low-income persons, reduce the total expenditures on energy, and improve their health and safety. Through funding received from the Colorado Governor's Energy Office, Energy Outreach provides assistance to low income multi-family dwellings for energy efficiency upgrades.
